6:35 p.m. Election Results

Haley reads election results. Haley, Joe, Gordie and George signed document to say results were accurate.

6 provisional votes were cast but not counted. 3 were added, 3 were not. 43% of membership voted.

Skip moves to accept these results.

Motion 101921b—Skip moves to ratify the results of the 2021 Constituency elections.

Russell friendly amendment to use ratify instead of accept accepted by Skip.

Ruth, member cannot be elected to a position that they are not qualified for. May 1 until April 30. Person must have been a member for the entire preceding year. Adora Lopez is not eligible for position of chair and must be removed from consideration.

Colleen, Adora did not stand for election.

Skip, membership year, misread the underlying documents.

John Coburn seconds

Christine, membership is determined by calendar year. Pass motion and put this to rest.

Skip offered to nominate Adora but she declined.

David says we need more legal advice.

Skip calls to question Christine seconds

2/3rds majority, Ruth.

Ruth says it's a tactic.

Ruth quotes the rule of Roberts calling for 2/3rd vote

Ruth, point of order, RROO, election that is contrary to bylaws or controlling documents it is tantamount to a motion

Colleen calls for a citation.

Christine, seek out legal counsel.

101921e- Christine moves that officers of the constituency seek legal opinion from PDA counsel as to the eligibility of the individual who was elected chair in the September Constituency election.

Skip seconds.

Christine, 23 members in question, wouldn't have changed results of election. No reason to carry it any farther. Inordinate amount of time.

Nick, securing legal counsel, 2021, by continuing to push and ask questions, wracked up a fairly astronomical legal bill.

Mark says Jay cites \$9,300 in legal expenses.

Nick, \$6,000 for next year. Should be wise in how we spend it.

Christine, over our heads, legal opinion will put it to rest. Otherwise, we'll spend 40 minutes at the next meeting.

Russell, PDA retreat, legal quandary, ask her to talk to Jerry to give us the proper legal guidance to ask for guidance.

Joan, we have not validated the election.

Colleen, citation? Strengthens Christine's motion.

Christine rescinds motion.

Back to Nick's motion.

David wants resolution from the auditors before supporting motion.

Christine heard clear statement from 2 of 3 auditors that there was nothing to contest.

Nick, 23 names.

Call to question.

Russell, names were cured so that they could vote. Most were typos.

Colleen, Cary Moon present at council meeting Auditors found nothing to negate the results. Not sure which lists Ms. Danner was looking at. 26 corrections, 18 members corrected US mail, 17 members were added.
